Learning outcomes: The seminar is conceived as a propedeutic introduction to practical scientific and theoretical-artistic research. Its target group is mixed and in the combination of peer discussions the seminar concept foresees the participation of PhD students in the theory and history of art and architecture as well as PhD students studying in the fine arts programme. The content of the seminar is designed to be a qualified preparation for the discursive articulation and textual formulation of the problem, process and results of scientific and artistic research in the field of visual art and its reflection. One of the focal points of the seminar's discourse is the precise and crisp articulation of a theoretical and/or artistic research problem, which the doctoral student must carry out well in advance during the first semester of study. Another focal point is centered on the articulation of the stylistic and genre possibilities of the text of the theoretical or artistic problem. In principle, the University does not limit the stylistic norms or genre attributes of the text of the doctoral written thesis, but deliberately opens up the space of possibilities so that each doctoral student can adapt this text into a form that best suits the needs of the research, while at the same time fostering an active creative approach to writing to the maximum extent possible. On the other hand, however, what is required is the correctness of the final document, which is actually a protocol of the research carried out and also a document of the paths of artistic thinking and reflection taken. Therefore, the seminar is also a propedeutic of formal correctness and the required formalities of a theoretical dissertation or the written part of a dissertation. The seminar work includes a common reading and analysis of selected texts of both good and unsatisfactory thesis and dissertation works realized in the environment of the Academy of Fine Arts and Design in Bratislava.
